

Benihana® Children Helping Children Sweepstakes Rules

The **Benihana Children Helping Children Sweepstakes**. These Rules apply to all participants. The Sponsors shall make all determinations as to whether the Rules have been complied with, and the decision of the Sponsors as to any issue is final.

Sponsor: Benihana National Corp Sponsors this Sweepstakes.

Eligibility: No purchase is necessary to participate in the Sweepstakes and participants must be 12 years of age or younger and be accompanied by a parent or guardian. A donation will not increase one's chance of winning. The Sweepstakes is open to residents of the 50 United States and United States Territories.

Entry: You will be entered to win by submitting a Children Helping Children Drawing Form to participating locations and drawing a picture on the form. You may also enter without drawing a picture by submitting a blank form but including your name and a parent or guardian's email address.

Time: For purposes of determining which who will be entered in the Sweepstakes, drawings will be counted only if they are submitted between 12:01 am Central Time on April 1, 2018 and 11:59 pm Central Time on May 5, 2018 ("the Sweepstakes Period"). The Winner will be determined and notified not later than 6:00 pm Central Time on June 1, 2018.

Prize: The prize consists of one dinner for up eight people at participating Benihana and Samurai locations up to \$300.

The estimated fair market value of the prize is \$300, but the actual value may differ.

Determination of Winner: There will be one winner per each participating location (the "Winners," each a "Winner") of the Sweepstakes. The Winners will be chosen by random selection from those who satisfy the entry requirements above. The drawing will be conducted privately, and no entrant is required to be present to win. The Winners will be notified by telephone or e-mail, and subsequently announced to the public. The selection of the Winners by the Sponsors is final and binding on all participants.

Consent to Publicity. By entering the Sweepstakes, the Winner consents to Benihana National Corp. use of his or her name and/or photograph in any publicity, publications, promotional and marketing material, advertising, and any other print materials, web pages, electronic or other communications published or distributed by Benihana National Corp., and to sign a separate agreement to this effect.
